ENVIRONMENTAL HEALTH/ZONING – WATER TESTNG LAB CLOSED FOR CALIBRATION OF EQUIPMENT:

Environmental Health/Zoning Director Scott Barnhart met with the Board to advise the water testing laboratory in his office will be closed for two to three weeks while the equipment is sent for calibration. The equipment is used for testing private water supplies.

EMERGENCY PREPAREDNESS – GRANT APPLICATION FOR FUNDS TO PURCHASE DRONE:

Emergency Preparedness Director Rick Whitson met with the Board for approval to submit a grant application for the grant being offered by Walmart in the amount of \$4,408.00 to purchase a drone to be used by Montgomery County law enforcement, emergency services and environmental health and zoning. He explained to the Board there can been many uses once the classes have been completed and a drone is put in service. A letter of support from the Board will be sent to Walmart. The Board approved this request.

EMERGENCY PREPAREDNESS (Continued):

Mr. Whitson advised the Board the refinery is giving a truck to Rural Fire and it will go to the Independence Fire Station.

He discussed an addition to the Independence Fire Station and will cost approximately \$40,000.00. No action was needed at this time.

A request was made for approval for some grass fire trucks from Montgomery County Rural Fire to be taken to the refinery and they will assist Montgomery County Rural Fire when needed and use these trucks. The Board approved the request.

MR. TIM JANAK – OWNER OF INDEPENDENCE COPORATE OFFICES:

Mr. Tim Janak met with the Board to discuss and provide plans for the remodeling of offices for Family and Children Services. Also attending the meeting was Mr. Duane Powell, Director of Family and Children Services and Ms. Lisa Goins representing County Attorney Larry Markle.

Mr. Janak advised the Board a third fire had been started in the building this morning. He said it was contained in a trash can in the building.

There was discussion on the problems the offices have had with heating, cooling and now being unable to work in the offices for considerable length of time due to the fires.

No decisions were made at this time and no commitment by Family and Children Services Representative for continuing to need or desire the remodeled area when it is completed.
