**SENATOR DAN GODDARD:**

Senator Dan Goddard met with the Board and to introduce himself and presented an update on bills that have been acted upon and those that were not. He also stated it is possible some of these will be brought up again when they reconvene.

The Highway 169 Project funding was discussed. He also spoke on Senate Bill 405 relating to chicken barns and the chicken industry. He said he would like to see more diversified crops being planted in Kansas due to heat and dry weather. He mentioned barley for an example.

**PUBLIC WORKS:**

Public Works Coordinator Robert Bever and Maintenance Supervisor Jeff Phelps met with the Board to discuss the chiller in the Judicial Building. The chiller has only four of the eight compressors working and is presently running on 3 compressors. The replacement cost is estimated at over \$50,000. Public Works will return t the Board with more information on replacement and cost.

**PUBLIC WORKS (Continued):**

Mr. Kenny Durst met with the Board and Public Works Coordinator Robert Bever to discuss County Road 1700 from Highway 166 to County Road 2000 (approximately 1.5 miles). The road was a paved road and has been turned back to rock. Mr. Durst said it has lowered the value of the homes on the road and he moved there because it was a hard surface road.

The Board will discuss it further with Public Works on the cost of possibly chip and seal. Mr. Durst will be contacted of their decision.
