Resolution No. 31-134

A RESOLUTION OF THE MONTGOMERY COUNTY RURAL FIRE DISTRICT #1 TO LEVY A PROPERTY TAX RATE EXCEEDING THE REVENUE NEUTRAL RATE;

WHEREAS, the Revenue Neutral Rate for the Montgomery County Rural Fire District #1 was calculated as 2.164 mills by the Montgomery County Clerk; and

WHEREAS, the budget proposed by the Governing Body of the Montgomery County Rural Fire District #1 will require the levy of a property tax rate exceeding the Revenue Neutral Rate; and

WHEREAS, the Governing Body held a hearing on September 20, 2021, allowing all interested taxpayers desiring to be heard an opportunity to give oral testimony; and

WHEREAS, the Governing Body of the Montgomery County Rural Fire District #1, having heard testimony, still finds it necessary to exceed the Revenue Neutral Rate.

NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY OF THE MONTGOMERY COUNTY RURAL FIRE DISTRICT #1:

The Montgomery County Rural Fire District #1 shall levy a property tax rate exceeding the Revenue Neutral Rate of 2.175 mills.

This resolution shall take effect and be in force immediately upon its adoption and shall remain in effect until future action is taken by the Governing Body.
