Page 409--"On motion, the road petitioned for by J. F. Armstrong, et al, was taken up for reconsideration after which it was ordered that Wm. Griffin, Samuel Young and J. W. Burke be appointed viewers to locate said road as near as practicable as prayed for in the petition." 10/9/1873

Road No. 209

Page 412--"On motion the petition of W. E. Dean, et al, in Liberty Township for the following described road, was received and viewers appointed. Road described as follows: commencing at a point on the section line between Secs. 11 and 14, T 33, R 16, where the road from Parker to Independence leaves said line, thence west along section line to the east bank of said Verdigris River, thence in a northerly direction along east bank of said river to the old Liberty ford, thence in a northwesterly direction crossing the river and intersecting the Parker and Independence Road on the $\frac{1}{2}$ sec. line running north and south through Sec. 11, also a road commencing on east bank of Verdigris river at the old Liberty ford, thence in a northerly direction along east bank of said river to the $\frac{1}{2}$ section corner between sections 2 and 11, T 33, R 16 E. The following persons were appointed viewers viz., D. R. Reese, J. W. Grew, and O. M. Webster." 11/7/1873

Page 422--"On motion the report of the surveyor and viewers of the road in Liberty township petitioned for by W. E. Dean, et al, was received and adopted and the board ordered open the road as surveyed and platted; 40 feet wide." 12/17/1873

Road No. 210

Page 405--"On motion, it was ordered that a survey be made of the road petitioned for by R. B. Crack, et al, in Louisburg Township described as follows, commencing at the NE corner of Sec. 16, T 32, R 14, thence west on section line one half mile, thence north 25 rods, thence NW on or near old Indian trail to intersect the road between sections 8 and 9, T 32 S, R 14 E." 10/9/1873

Page 422--"On motion, the report of surveyor and viewers of the road in Louisburg Twp. petitioned for by O. B. Crack, et al, was received and adopted and the road ordered open as surveyed and platted--40 feet wide." 12/17/1873

Page 407--"On motion, it was ordered that in accordance with the petition of Wm. M. Robinson, et al, in Fawn Creek Township, asking for the vacation and relocation of a road, that the same be granted, described as follows: Vacation to be the section line between sections 9 and 10, Twp. and range above named. Relocation commencing at the NW corner of the NE $\frac{1}{4}$ of Sec. 9, T 34, R 15, thence south to the south line of said section. The following persons were appointed viewers: J. M. Eaton, Samuel Glaze, and James Sweringer." 10/9/1873

Page 422--"On motion, the report of the surveyor and viewers of the road in Fawn Creek Twp. petitioned for by Wm. Robinson, et al, was received and adopted and the road ordered open as surveyed and platted--40 feet wide. Vacation not allowed." 12/17/1873

Page 406--"On motion, a survey was ordered to be made upon the road petitioned for by A. K. Johnson, et al, in Rutland Township, described as follows: Commencing at the NE corner of the NW $\frac{1}{4}$ of the NE $\frac{1}{4}$ of Sec. 35, T 33, R 14, thence south $\frac{1}{2}$ mile, thence west $\frac{1}{2}$ mile to intersect the road running north and south between sections 34 and 35, and vacating the $\frac{1}{2}$ mile now located between sections 26 and 35. The following persons are hereby appointed viewers: Wm. Stewart, D. W. Kingsley, J. F. Lattimore." 10/9/1873

Page 423--"On motion, the petition of George Foster, et al, in Parker Twp. for the following described road, was granted and viewers appointed. Description: Commencing at the SE corner of the SW $\frac{1}{4}$ of Sec. 10, T 34, R 16, thence north through Secs. 10 and 3 to the Twp line. Viewers: A. J. Conner, John Moore, H. C. Vesch." 12/29/1873

The undersigned also petition for the abandonment of the road angling SE from the point mentioned on said section line to about the center of the SW $\frac{1}{4}$ of Sec. 5, thence running SW to about the center of the NE $\frac{1}{4}$ of Sec. 5, thence running SW to about the center of the NE $\frac{1}{4}$ of Sec. 7. Page 406--"On motion a survey was ordered to be made upon the road petitioned for by Wm. H. Cox, et al, in Louisburg Township, described as follows, commencing at the NW corner of Sec. 20 in T 31, R 14, thence east $1\frac{1}{2}$ miles to the section line between Sections 16 and 21, thence north 20 rods, thence east about 90 rods to the west bank of Duck Creek, thence in a Southeasterly direction along the west bank of said creek to a convenient ford about 4 rods south of said section line, thence east to the east line of said township. The following persons are hereby appointed viewers: A. Owens, Jr.; S. D. Kelley, and H. H. Hare." 10/9/1873

McKinney, et al, in Parker Township, described as follows: Beginning at the SE corner of the SW $\frac{1}{4}$ of Sec. 32 T 34, R 16, thence west on Twp. line to the creek, thence on south bank of creek to said Twp. line, thence west on said Twp. line to the bluff, thence south along the foot of said bluff to the strip line. This being a relocation of a portion of the state road; it was ordered that the road overseer of the proper district, with the surveyor relocate said road in accordance with the petition." 10/9/1873
