Human Resources Director Ben Brubaker, Sheriff Ron Wade, Department of Corrections Captain Chad Dunham, Undersheriff Chris Williams and Financial Officer Fred Gress were present at the meeting to discuss the Department of Corrections compensation.

Human Resources Director Ben Brubaker presented information to the Board proposing an increase to the starting Department of Corrections floor pay. The proposal recommends increasing the base hourly wage from \$15/hr to \$17/hr with an additional \$1/hr after completion of one year on the job and passing a competency evaluation. It was recommended in the information to the Board that to accomplish the training requirement an additional Sergeant title would be added to support training staff and leaders. This would no increase the DOC number of employees. The following action was taken:
