# Dated at Montgomery County, KS this 23rd day of October, 2023

## **DECLARATION OF LOCAL DISASTER EMERGENCY**

WHEREAS on the 23<sup>rd</sup> day of October 2023, the Board of Commissioners of Montgomery County, Kansas did consider the current availability of potable water within the County in general and the area of Caney, Kansas in particular;

WHEREAS drought conditions in Kansas have caused exceptionally low water levels in the Little Caney River, and this has physically reduced the ability of the City of Caney to produce potable water in sufficient quantity to support residential, educational, commercial, and other water customers in its service area;

WHEREAS both the uninterrupted supply of potable water and continuous provision of education services are defined as vital community lifelines by the Federal Emergency Management Agency;

WHEREAS the use of water conservation methods in the Caney water service area has reduced consumption, yet this has been insufficient to restore the community lifelines of water supply and educational systems;

WHEREAS on the 15<sup>th</sup> day of August 2023, the Governor of the state of Kansas issued Executive Order 23-04 pursuant to K.S.A. 74-2608, acknowledging that drought conditions continue to exist in Kansas, and further declaring Montgomery County, Kansas to be categorized as in a condition of 'drought emergency';

WHEREAS the drought has led to extreme measures including the use of a four day school week instead of a five day week at all schools in Unified School District 436, strict control of water usage in USD 436, hardship for the residents of the Caney area, and reduced production at area factories, and

WHEREAS the City of Caney and Unified School District 436 have both requested emergency assistance from the Board of County Commissioners of Montgomery County, with the goal of maintaining the community lifelines of educational services and water supply to residents of Caney and the surrounding area;

IT IS THEREFORE RESOLVED that the Board of County Commissioners of Montgomery County Kansas does hereby declare a State of Local Disaster and Emergency for the water shortage event within Montgomery County Kansas.
