I am writing this letter to help you better understand the use of the transient guest tax that the City of Cherryvale receives from Montgomery County. In 2021 Montgomery County Commissioners passed a resolution that split the disbursement of the transient guest tax up giving Cherryvale 5% of all tax dollars that came in. The reason the City of Cherryvale received those funds was due in part to the fact that the commissioners did not feel comfortable sending those tax dollars to the Cherryvale Chamber of Commerce. The reason they did not feel comfortable with that is because the Cherryvale Chamber lost their 501c3 status. Because of this they would be giving tax dollars to an organization that was not able to handle tax dollars properly. Therefore because of this, they sent the funds to the City of Cherryvale to manage and release to the Cherryvale Chamber as they saw fit.

The City of Cherryvale would receive the payments in from Montgomery County and would pay out, according to the Montgomery County Commissioners, anything that was tourism related. Because of this stipulation the Cherryvale Chamber would send the City of Cherryvale receipts for items they had spent on tourism, such as Cherry Blossom Festival, tourism brochures, museum donations, etc., and the City of Cherryvale would send them a check for the amount requested. The City of Cherryvale has always budgeted this money and paid out the money based on what is requested. The City has never given a large sum of money to the Chamber because they haven't held a 501c3.

As recent as the end of 2023 to the beginning of 2024, the Cherryvale Chamber of Commerce officially got their 501c3 designation back. Because of this, they now have the capabilities of handling the transient guest tax moving forward, as long as they maintain their status. This would enable the City of Cherryvale to relinquish control of those funds and allow the Chamber to spend them how they see fit, without using the City as a "Middle Man" when they need funds. This would open up a source of funding they have never had access to in the past and allow them to operate as a legitimate organization here in Cherryvale.
