COFFEYVILLE REGIONAL MEDICAL CENTER GRANT:

County Administrator Jonathan Booe and Financial Officer Fred Gress presented information on the 1.7 million dollar grant awarded to the Coffeyville Regional Medical Center. The funds will be sent through the County for disbursement to CRMC. It was decided Mr. Booe will work with CRMC on issuing one-half of the funds in the first disbursement and the remainder disbursed as project proceeds.

COUNTY ADMINISTRATOR – GRANT CONSULTANT:

County Administrator Jonathan Booe provided information to the Board after reaching out to some individuals and also to agencies. He has received three responses. One of the responses was from Merchant McIntyre Agency in Washington DC who works on a retainer per month. The retainer is \$8,000.00 per month. Another response quoted \$65,000.00 per year.

Mr. Booe recommended we use Merchant McIntire Agency and has had good references from four other counties. The Board approved moving ahead with a contract after he contacts County Counselor Paul Kritz.

COUNTY APPRAISER - UPDATE ON ABATEMENT OF TAXES FORM:

County Appraiser Melody Kikkert met with the Board to present a new form which will be used by the County Appraiser's office and the County Clerk's office for report totals per year on abatement of taxes which will include the name of the taxpayer on the abatement, amount of taxes and reason for the abatement.

MILEAGE REIMBURSEMENT INCREASE:

County Administrator Jonathan Booe recommended to the Board the mileage reimbursement for employees when using their own vehicles be increased from \$.54 cents per mile to \$.67 cents per mile.
